Deposit Guarantee Fund	Deposits held at Banco BPI benefit from a reimbursements guarantee provided by the Deposits Guarantee Fund (the Fund) whenever the deposits are not available for reasons directly related to Banco BPI's financial situation. The Fund guarantees reimbursement up to a maximum of €100,000.00 per depositor. The calculation of the amount of deposits of each depositor takes into account the amount in all the deposit accounts on the date on which the unavailability of payment occurred, including interest and, for deposits in foreign currency, these are converted into Euros at the exchange rate on that date.
