

- Financial markets ended the week on a sour note. U.S. and EM stocks dropped by close to 2% and 1.5%, respectively, and erased the week's gains. Losses also spread to the Eurozone, where the main indices declined somewhat less than 1%.
- In fixed-income markets, U.S. and German sovereign yields edged lower and euro area peripheral spreads nudged up. Nonetheless, on a weekly basis, easing tensions around Italy's fiscal policy led peripheral spreads to consolidate their marked decline.
- In FX markets, the euro eased towards \$1.13 and most EM currencies depreciated against the USD.
- In oil markets, the price of the barrel of Brent fluctuated moderately above \$60.
- Eurozone sentiment indicators continued to trend lower in December. The flash composite PMI declined to 51.3 points in the Eurozone (Nov.: 52.7) and to 49.3 points in France (Nov.: 54.2), while the German index stood roughly stable at 52.2 points (Nov.: 52.3).
- This week, the focus will be on the monetary policy meetings of the U.S. Federal Reserve (Wednesday), the Bank of Japan (Thursday) and the Bank of England (Thursday).

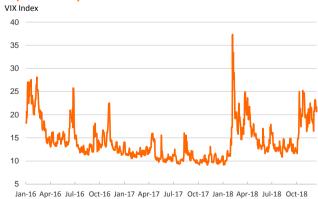
#### Risk Premium on 10-year debt: Italy, Spain and Portugal
